**Subject: Management Report on the Audit of Accounts of Bangladesh Freedom Fighter's Welfare Trust for the year ended 30<sup>th</sup> June 2020.**

Dear Sir,

We have audited the financial statements of **Bangladesh Freedom Fighter's Welfare Trust**, for the year ended 30<sup>th</sup> June 2020 and submitted our statutory Auditors' Report to you. In addition to that, we take this opportunity to share our observations on operational processes and financial statements which should be addressed by the management.

Our examination has been carried out following Generally Accepted Auditing Standards and accordingly included such test and examination of accounting records and such other auditing procedures as we considered necessary in the circumstances. Our audit procedures were conducted on a test check basis to enable us to form an opinion on the Financial Statements of the Bangladesh Freedom Fighter's Welfare Trust as a whole.

#### **Scope of Audit**

We conducted the audit following International Standards on Auditing (ISA) as adopted in Bangladesh. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the Financial Statements are free of material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the Financial Statement. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall Financial Statements Presentation. We have designed the audit in a manner for enabling us to authenticate and assess the fairness as well as the appropriateness of financial transaction along with the assessment of adequacy and effectiveness of related internal control thereof and to measure the adequacy and the degree of compliance with the policies, rules and procedures of the entity. As a result, our audit included such tests of accounting records, books vouchers, registers and other relevant documents such as other auditing procedures as were considered necessary deemed appropriate and found feasible under the individual circumstances.

It is pertinent to mention here that our audit procedures are primarily designed to enable us to form an opinion on the Financial Statements and the fulfillment of the rules and procedures of the entity.

The scope of our work, inter alias included the followings:

- ❖ To provide an opinion on the truth and fairness of the Financial Statements prepared by the organisation.
- ❖ To examine inventory management process and recommendation for betterment.
- ❖ To check inventory and receipt vouchers on a test basis and validate with authority limit.
- ❖ To assess the Internal Control System of the unit and give a recommendation.

#### OBSERVATIONS & FINDINGS:

##### 1.00 Un-Finalized Audit Report

The audit report for 2017-2018 and 2018-2019 has not been prepared yet. Management should take necessary actions to acquire the audit report for the mentioned Financial Years.

##### 2.00 Unable to obtain FDR documents:

We were unable to verify the total amount relating to the FDR from the schedule of FDR. We were unable to obtain any supporting documents regarding FDR interest calculation, as a result the actual amount consisting of principle and interest amount could not be determined.

Sec-11/1741-F.R. dated 12-10-1972. It has been carried forwarded from last year's account. Management is requested to make necessary adjustment the amount.

**5.00 Bangladesh Assistance Committee (New Delhi):**

During the course of our audit period, we observed that BFFWT received Tk. 5,000,000.00 from Bangladesh Assistance Committee (New Delhi) for investment in long term bank deposits with stipulated that the income thereof should be used for giving assistance to Freedom Fighters in cash or in kind for their welfare, define in clause two (2) of Bangladesh Freedom Fighters Welfare Foundation order 1972. The above balance was received through the High Commission of India in Dhaka vide there after letter no. Dac/ECO/17/28/72 dated 13-01-1973. It has been carried forwarded from last year's account. Management is requested to make necessary adjustment.

The balance of sundry debtors is showing in the account for a long period of time. Management should take necessary steps to find the Debtors and collect the receivable.

**10.00 Incorrect amount at VAT deducted at source:**

On 30<sup>th</sup> May 2020, VAT deducted at source in the ledger book shows Tk. 418,764.96. However, in the Note 10, our calculation shows Tk. 424,925.76. The difference is Tk. 5,530. Management should take necessary steps to adjust the amount.

**11.00 Documents for Fixed Assets Addition:**

During the FY 2019-20, we could not obtain the supporting documents for addition of fixed assets for Office Equipment and Computer.
